ORDER

No. РД-11-282 Sofia, 14.04.2020

RE: Repealing the temporary organization of the traffic on sections of the Republican road network of motor vehicles intended for the transportation of goods with a technically permissible maximum mass exceeding 12 tonnes, including trailer and semi-trailer compositions, agricultural and farming machinery, tractors and specialized construction equipment.

Pursuant to Art. 9, para. 4 and para. 5, Art. 21d, item 1 and item 6 and Art. 21c, para. 2 of the Roads Act and Art. 165, para. 1, item 8 of the Road Traffic Act, Art. 73 of the Administrative Procedure Code, in conjunction with Art. 10, para. 1, item 23 and para. 4 of the Rules concerning the Structure, Operations and Organization of the Work of the Road Infrastructure Agency (RIA), as well as in implementation of Decision No. 226 of 2 April 2020 of the Council of Ministers of the Republic of Bulgaria and a Decision of the Management Board of the RIA, reflected in Minutes No. 25016/20 of a meeting held on 10.04.2020.

I HEREBY ORDER:

- I. To be repealed temporarily Order PД-11-1496 of 16.12.2019 in relation to Measure 12 of the Action Plan of the Republic of Bulgaria on the Communication from the European Commission on the implementation of the Green Lanes under the Guidelines for border management measures to protect health and ensure the availability of goods and essential services, approved by Decision No. 226 of 2 April 2020 of the Council of Ministers of the Republic of Bulgaria.
- II. This order is to be sent to the District Road Authorities (DRA), the General Directorate National Police of the Ministry of Interior, the Executive Agency Road Transport Administration at the MTITC, the Traffic Police Department/Sector at the Regional Police Directorates of the Ministry of Interior and the Sofia Municipality Police Directorate (TPD/TPS at the SMPD/RPDMI), the National Coordination Center for Safe Road Traffic (NCCSRT) for information, implementation and carrying out of direct control.

This Order is to be published on the official website of the Road Infrastructure Agency and to be placed on the notice board located in the building of the Central Administration of the Road Infrastructure Agency, at: 3, "Makedonia" Sq.

Pursuant to Art. 179 of the Administrative Procedure Code, this Order may be appealed within one month of its publication on the website of the Road Infrastructure Agency
