I. Having received and considered the bidding documentation, with this technical bid we submit the following binding proposals for the implementation of the public procurement contract, inclusive as follows:

Term for implementation of the additional design and the construction and assembly works (CAW) under the contract

Hereby we offer, in accordance with the Construction Schedule under the contract, a term for implementation of the additional design and CAW under the contract – [months (in figures and in words)] as from the signing of Protocol form N_{2} a for the opening of construction site and the determination of construction line and level for the construction of technical infrastructure¹ until drafting of a Statement of Findings (SOF) form $N_{2}15$ for verification of construction site acceptability².

II. Organisation and execution of construction works:

II.1. In executing the construction works we shall use equipment, including testing and examination equipment, thereby ensuring quality control of completed construction and assembly works as described in the list enclosed as Appendix N_{2} 9 to the bidding documentation.

II.2. We shall implement the public procurement contract under the technical supervision of persons engaged in carrying out the technical supervision of construction works, including the provision of quality control (management staff) listed by name in Appendix \mathbb{N} 11 to the bidding documentation and workers (professionals and technically qualified staff) in number and with qualifications in accordance with Appendix \mathbb{N} 12 to the bidding documentation

II.3. We shall make any change in the equipment as per section II.1 hereinabove, in the management staff and in the number and qualifications of the workers and employees under section II.2 hereinabove at our own risk regarding the quality and the term for execution of the construction and assembly works (CAW) according to the procedure as provided for in the contract for award of public procurement.

II.4. We shall implement the awarded public procurement in accordance with the Construction Schedule³ under the contract, which is submitted as enclosure to our tender bid as Appendix N_{2} 5.1 to the bidding documentation, with duration and sequence as follows

Stage I, comprising, shall have a duration of (in figures and in words) days from signing Protocol form N_{2} 2a for the opening of the construction site and determination of construction line and levels for building of technical infrastructure⁴.

- a separate stage for implementation of information and publicity measures shall be indicated in compliance with XVII from the contract for award of public procurement, amounting exactly 100 000 (one hundred thousand) BGN, VAT excluded

- the value of each stage, except the stage for implementation of information and publicity measures and the last four, shall be not less than two (2) % and more than 5 (five) % of the total price of the contract;

- the value of each of the last four stages can not be less than 10 (ten) % of the total price of the contract;

- the stages shall be stated as consecutive in time, whereas the stage referred to with a previous number shall end before the stage indicated with a subsequent number. This requirement does not apply to the stage for implementation of information and publicity measures.

- stages' distribution shall be made in a way to show and ensure the following:

a. by the end of the 50th day following the date of drafting and signing of Protocol form N_{2} 2a under Ordinance N_{2} 3 for permission of beginning the construction works and determining the level for either part of construction site, earthworks shall be commenced;

b. by the end of the 8th month following the date of drafting and signing of Protocol form No 2a, 30% of earthworks and 25% of concrete works shall be completed, 15% of loose mineral materials shall be laid and compacted; they comprise finishing of zone A – 50 cm to the earth bed and a foundation of crumbled stones with permanent grain size of 0-60 from the road surface construction;

c.by the end of the 15^{th} month following the date of drafting and signing of Protocol form No 2a, 90% of earthworks and 80% of concrete works, 60% of crumbled stone with permanent grain size of 0-40 mm and 40% of bituminized ballast layer shall be completed, and 70% of loose mineral materials shall be laid and compacted; they comprise finishing of zone A – 50 cm to the earth bed and a foundation of crumbled stones with permanent grain size of 0-60 from the road surface;

- organization and preparation of activities, falling within the scope of additional design and construction and assembly works may not be defined in a separate stage.

III. In order to secure the implementation of contract for award of public procurement, we shall submit to the Contracting Authority, prior the contract signing, a performance guarantee amounting to 5 (five) percent of the contract price, excluding VAT, as indicated in the price bid. We shall provide for guarantee validity of 60 (sixty) months after the commissioning of the entire construction site by issuing a Use Permit.

IV Warranty periods⁵ for guaranteeing the normal functioning and use of the completed construction site and removal of any hidden defects that may appear after the commissioning of the construction site.

Hereby we acknowledge the following warranty periods

IV.1. Warranty period for the completed Construction and Assembly Works on the site, with the exception of facilities⁶ – 60 months (sixty months).

IV.2. Warranty period for the completed facilities⁷ – 120 months (one hundred and twenty months).

V. Within the warranty periods as set in this offer for the maintenance of the construction site we acknowledge our liability, in accordance with the proposed draft contract, to perform the repair of all and any faults and defects that may appear in the completed Construction and Assembly Works on the site, including the facilities, to maintain the quality and the continuous operation of the site in accordance technical specifications, submitted with the bidding documentation. Our warranty liability shall be waived off whenever the detected faults and defects are the result of "force majeure" circumstances ("irresistible force") as set forth in the contract for award the public procurement.

VI. Hereby we declare that we want / do not want⁸ to receive a down payment amounting to 5 (five) percent of the contract price in return of providing a guarantee to provide for the down payment under the terms and conditions of the draft contract.

In case of discrepancy in the numeric figures and their wording in this offer, we shall consider the spelled in wording as binding one.
